RDG-91 - later departure Newberry Jct.

The changes on the schedule sheet are,


92 discontinued east of Hornell.

84 includes, All other for Wyoming Division and inserts the word "Lima" for the words "Chicago and St. Louis".
BX-90 insert the word "Lima" for the words "Chicago and St. Louis".
NY-90 eliminate, All for Wyoming Division.
